4a (Code:) (Expenses \$ 1,873,813. including grants of \$) (Revenue \$) Teen Pregnancy Prevention - GCAPP leads this collective impact initiative of 20 partner organizations representing education, child welfare, public health, juvenile justice, youth development, and academia. While teen pregnancy is down in Georgia by 72%, we are working to reduce teen births by another 25% by 2025. The Second Chance Homes network provides wrap-around care for teen mothers and their children; empowers teen mothers to finish high school, gain skills, and become self-sufficient parents; and works to reduce repeat teen pregnancies. The Eban Initiative is a multi-dimensional, culturally tailored project that connects mentors with young African-American males ages 15-19 in Clayton County.

4b (Code:) (Expenses \$ 655,387. including grants of \$) (Revenue \$ 22,265.) Comprehensive Sex Education - One of GCAPP's steadfast and foundational beliefs is that sex ed is for life. GCAPP recognizes that young people need and deserve sex ed, and that it should be given parity in the classroom and taught just as any other subject. GCAPP currently works with 17 school districts, 215 schools, and serves thousands of students with age-appropriate, medically accurate comprehensive sex education.

4c (Code:) (Expenses \$ 85,203. including grants of \$) (Revenue \$) Youth Empowerment - GCAPP helps young people avoid situations that can result in lifelong, difficult circumstances that, statistically, many will never overcome. Our Youth Advisory Council members help us design training, curricula, and online content that is relevant and valuable for their peers while serving as ambassadors for our mission in their home communities and on college campuses. Through our college strategy, we partner with campus health and wellness departments to integrate sexual health information into online coursework.
